

KidControl Parental Consent Form

Children under the age of 13 are not able to use the KidControl application without the written permission of the parent or legal guardian.

Children under the age of 13 cannot use the “ KidControl app without permission of the parent or legal guardian in accordance with the Children's Online Privacy Protection Act of 1998 year (COPPA).

A parent or guardian must submit this form to add a child under the age of 13 as a child in account in «KidControl» application. After you have given your consent to the child to use the Services, KidControl starts to collect the following information of the child:

- device ID.and motion sensor and location data including GPS, WiFi and mobile location
- avatar photo. You can use a picture that not identify your child.
- GPS-watch photos.
- sound around the GPS watch: broadcasting an audio signal at the request of the parent allowed only to the users connected to the same account.
- access to device usage statistics: the purpose of displaying the battery charge , sound mode of child's phone, information on the percentage of spend time in other applications in a solely parent account.

We do not collect information regarding the child's first and last name, any nickname can be used as a user name. Company will disclose information described above to other members of the parent account and the child will be available to send and receive messages from other members of parent account. Access to the parent account is only by invitation. Company may also share personal information, including location information collected from a child under 13 with our third-party service providers or partners, as described in our Privacy Policy (<https://kid-control.com/privacy-policy/>).

However the Company will not use or share the personal information of a Child under the age of 13 to any third-party partners for the promotional and advertising purposes.

Parent or guardian consent is required for the collection, use or disclosure of information from children under the age of 13.
